	THE ALLBRITTON JOURNALISM INSTITUTE (THE INSTITUTE) OFFERS A TWO-YEAR PROGRAM DESIGNED TO EQUIP STUDENTS FROM A DIVERSE RANGE OF BACKGROUNDS FOR CAREERS AS CREDIBLE, NON-PARTISAN REPORTERS. THE CURRICULUM PROVIDES OUR STUDENTS BOTH A RIGOROUS EDUCATION IN CORE JOURNALISTIC SKILLS AND HANDS-ON EXPERIENCE COVERING GOVERNMENT AND POLITICS. STUDENTS ARE ENROLLED FULL-TIME FOR THE DURATION OF THE TWO-YEAR PROGRAM, TAKING REGULARLY SCHEDULED COURSES TAUGHT BY THE INSTITUTE'S FACULTY AS WELL AS GUEST LECTURERS. FORMAL INSTRUCTION IS CONDUCTED IN A VARIETY OF FORMATS, INCLUDING LECTURES, SEMINARS AND DISCUSSION GROUPS. STUDENTS ALSO RECEIVE PRACTICAL, REAL-WORLD TRAINING BY WORKING TOGETHER WITH FACULTY MEMBERS WHO ARE PROFESSIONAL EDITORS AND REPORTERS TO PRODUCE (SEE SCHEDULE O) A NEW DIGITAL PUBLICATION COVERING GOVERNMENT AND NATIONAL POLITICS.
