WE WORKED WITH ENVIRONMENTAL JUSTICE AND WORKERS RIGHTS PARTNERS TO STRENGTHEN PROTECTIONS FOR OUTDOOR AND OTHER FRONTLINE WORKERS AGAINST CLIMATE-FUELED EXTREME HEAT AND WILDFIRE SMOKE. OUR ADVOCACY HELPED PASS LEGISLATION PHASING OUT SINGLE-USE PLASTIC USED IN FOOD CONTAINERS (IN TURN LIMITING EXPOSURE TO PFAS), AND REDUCING E-WASTE (AND THEREBY LEAD, MERCURY AND CADMIUM).
