Editorial Production: Journalists created articles, videos, photos, and other content that helps Long Beach residents understand local power structures and access essential news for their safety and wellbeing. The organization published investigations that led to increased transparency, including reporting on environmental impacts of a local construction project and alleged theft by a local food bank. Coverage provided residents vital information during federal immigration enforcement actions. Reporting illuminated city decisions and processes through coverage of local government meetings, public safety, health, and other critical community issues, enabling accountability of leaders to taxpayers and residents.

Community outreach and engagement: The organization published a Long Beach 101 Civic guide connecting residents with their elected leaders and a guide highlighting and celebrating tourist attractions in the city.
