NPH PROMOTES THE PROVEN METHODS OF THE NON-PROFIT SECTOR AND FOCUSES GOVERNMENT POLICY ON HOUSING SOLUTIONS FOR LOWER INCOME PEOPLE WHO SUFFER DISPROPORTIONATELY FROM THE HOUSING CRISIS.

NPH LEADS REGIONAL AND STATE POLICY, ADVOCACY AND CAMPAIGNS FOR AFFORDABLE HOUSING AND RACIAL AND ECONOMIC EQUITY, AND ADVANCES SOLUTIONS TO THE AFFORDABLE HOUSING CRISIS. NPH PROVIDES ESSENTIAL PROGRAMS AND TRAININGS TO STRENGTHEN THE AFFORDABLE HOUSING INDUSTRY AND MOVEMENT, INCLUDING COALITION BUILDING, PEER LEARNING AND NETWORKING OPPORTUNITIES, CULTIVATING BEST PRACTICES AND INNOVATION, AND ADVANCING RACIAL EQUITY AND INCLUSION IN OUR SECTOR. COVID RESPONSE & RECOVERY IN 2020, NPH MOBILIZED CONSTITUENTS FROM SAN FRANCISCO, THE BAY AREA AND THROUGHOUT CALIFORNIA TO CALL FOR SWEEPING RENT RELIEF IN ANY COVID-19 RELIEF PACKAGE AND CLASSIFYING AFFORDABLE HOUSING AS ESSENTIAL INFRASTRUCTURE IN FUTURE COVID-19 RECOVERY BILLS. NPH WAS SUCCESSFUL IN GAINING LAWMAKERS' ATTENTION, INCLUDING SPEAKER NANCY PELOSI, AND HELPING TO SPOTLIGHT AND ADVANCE THESE PRIORITIES. NPH ALSO BROUGHT THE SUPPORT OF THE BAY AREA AFFORDABLE HOUSING COMMUNITY TO EFFORTS BEING LED BY TENANT GROUPS FROM ACROSS THE STATE TO PUSH FOR AB 3088 (CHIU), WHICH CREATED THE NATION'S STRONGEST EVICTIONS PROTECTIONS IN RESPONSE TO THE PANDEMIC. NPH CONTINUED TO ADVANCE STATE LEGISLATIVE AND REGULATORY PRIORITIES WITH MEMBERS AND COALITION PARTNERS. AFFORDABLE HOUSING CAMPAIGNS ALSO IN 2020, NPH BROUGHT TOGETHER RESIDENT SERVICES STAFF FROM ACROSS THE REGION FOR WORKSHOPS FOCUSING ON RESIDENT VOTER REGISTRATION IN THE ERA OF COVID-19, HOW TO ENCOURAGE VOTER TURNOUT AND LONG-TERM ADVOCACY OPPORTUNITIES VIA A PROFESSIONAL DEVELOPMENT SERIES CALLED COMMUNITY ADVOCACY AND VOTER ENGAGEMENT (CAVE). THROUGHOUT THE NINE BAY AREA COUNTIES, 27 NPH MEMBER ORGANIZATIONS AND 70 RESIDENT SERVICE STAFF PARTICIPATED TO GAIN A DEEPER KNOWLEDGE OF VOTER ENGAGEMENT AND ADVOCACY. WITH THE HELP OF OUR MEMBER ORGANIZATIONS, NPH DISTRIBUTED 75,000 PIECES OF VOTER EDUCATION COLLATERAL IN EIGHT DIFFERENT LANGUAGES ON VOTER REGISTRATION, VOTER RENEWAL AND THE 2020 VOTING PROCESS. NPH HELPED LEAD COALITION AND PARTNERSHIP EFFORTS TO SUPPORT OUR REGIONAL AGENCIES, ABAG AND MTC, TO ESTABLISH THE BAY AREA HOUSING FINANCE AUTHORITY (BAHFA) AND DEVELOP THE INITIAL PROGRAMMING. BAHFA IS THE OUTCOME OF SUCCESSFUL NPH-LED LEGISLATION IN 2019. NPH PUBLISHED THE ROAD AHEAD: A 21ST CENTURY HOUSING STRATEGY FOR THE SAN FRANCISCO BAY AREA, WHICH OUTLINES STEP-BY-STEP HOW BAHFA, AS PART OF THE METROPOLITAN TRANSPORTATION COMMISSION (MTC) AND THE ASSOCIATION OF BAY AREA GOVERNMENTS (ABAG), POSITIONS THESE AGENCIES TO MAKE MEANINGFUL CHANGES FOR OUR REGION TO LEAD US OUT OF THE HOUSING CRISIS AND TO A MORE EQUITABLE, THRIVING BAY AREA. PROGRAMS & TRAININGS DUE TO THE COVID PANDEMIC, NPH PIVOTED TO ALL VIRTUAL EVENTS DURING 2020, IN ORDER TO CONTINUE TO OFFER CRITICAL CAPACITY BUILDING OPPORTUNITIES THROUGH OUR ANNUAL CONFERENCE, PROGRAMS, AND TRAININGS. THE 2020 CONFERENCE BROUGHT TOGETHER NEARLY 1,000 MEMBERS AND SUPPORTERS TO DRILL DOWN ON TECHNICAL HOT TOPICS, COVID-19 IMPACTS ON AFFORDABLE HOUSING WORK, AND HOW OUR INDUSTRY CAN CENTER RACIAL JUSTICE IN OUR DAY-TO-DAY WORK. OUR RESIDENT SERVICES TRAINING SERIES ADDRESSED THE UNIQUE NEEDS OF RESIDENT SERVICES PROFESSIONALS WITH A FOUR-PART COACHING SERIES, PEER SHARING ON COVID-RESPONSE STRATEGIES, AND A TRAINING ON ENGAGING RESIDENTS IN THE CENSUS. OUR EMERGING LEADERS PEER NETWORK (ELPN) ORGANIZED SIX TRAININGS AND TWO NETWORKING VIRTUALLY, ENSURING THAT UP-AND-COMING AFFORDABLE HOUSING LEADERS HAVE THE TOOLS THEY NEED TO STRENGTHEN OUR INDUSTRY. AND OUR 2020 BROWN BAG WORKSHOPS OFFERED LEADERSHIP DEVELOPMENT OPPORTUNITIES AND COLLABORATIVE SESSIONS FOR AFFORDABLE HOUSING PROFESSIONALS ACROSS ALL SECTORS - PUBLIC, PRIVATE, AND NON-PROFIT - TO OVER 1,000 ATTENDEES. SHIFTING THE HOUSING NARRATIVE NPH CONTINUED OUR WORK LEADING THE SHIFT THE NARRATIVE COLLABORATIVE (STN) IN 2020. STARTED IN 2018, NPH SERVES AS THE ANCHOR ORGANIZATION FOR OVER 18 COMMUNITY ORGANIZATIONS THROUGHOUT THE BAY AREA TO ASSESS, EVALUATE, RESEARCH AND IMPLEMENT THE MOST EFFECTIVE MESSAGING FRAMEWORKS TO ADVANCE HOUSING JUSTICE AND RACIAL JUSTICE. IN 2020, STN CREATED NEW MESSAGE GUIDES AND TOOLS, EXECUTED NEW RESEARCH, AND PRODUCED THE SEIZE THE NARRATIVE PLAYBOOK TO REACH AND SUPPORT MORE THAN 200 ORGANIZATIONS AND 400 INDIVIDUALS SPANNING MULTIPLE INDUSTRIES AND ISSUE AREAS TO ADVANCE HOUSING JUSTICE. ADVANCING RACIAL EQUITY IN 2018, BUILDING UPON PREVIOUS WORK, NPH LAUNCHED A RACIAL EQUITY AND INCLUSION INITIATIVE THAT INCLUDES COMPREHENSIVE PROGRAMMING FOR THE AFFORDABLE HOUSING INDUSTRY AND INTEGRATES RACIAL JUSTICE INTO OUR POLICY AND ADVOCACY CAMPAIGNS. SO FAR, OUR RACIAL EQUITY AND INCLUSION WORK HAS RECRUITED AND CULTIVATED NEW LEADERS OF COLOR INTO THE AFFORDABLE HOUSING DEVELOPMENT FIELD THROUGH OUR BAY AREA HOUSING INTERNSHIP PROGRAM (BAHIP); SUPPORTED AND UPLIFTED EMERGING LEADERS OF COLOR; ASSISTED MEMBER ORGANIZATIONS IN ADVANCING THEIR OWN RACIAL EQUITY ACTION PLANS; AND WORKED WITH OUR MEMBERS TO BUILD COALITIONS AND CAMPAIGNS THAT SHIFT CULTURE AND PRIORITIZE RACIAL JUSTICE. IN 2020, NPH CONTINUED THIS WORK AND LAID THE FOUNDATION FOR THE LEADERSHIP DEVELOPMENT TRAINING INSTITUTE, A NEW PROFESSIONAL DEVELOPMENT PROGRAM DESIGNED TO ADVANCE MID-CAREER MANAGERS OF COLOR TO SENIOR AND EXECUTIVE POSITIONS IN OUR INDUSTRY. NPH ALSO PREPARED TO LAUNCH OUR NEW RACIAL EQUITY RESOURCE LIBRARY IN JANUARY OF 2021, CREATED WITH THE GOAL TO ASSIST OUR MEMBERS AND OTHER SUPPORTERS AS THEY UNDERTAKE THE JOURNEY TOWARD EMBEDDING RACIAL JUSTICE WORK INTO THEIR ORGANIZATIONS. THE LIBRARY PROVIDES ACCESS TO THE MOST UP-TO-DATE RESOURCES ON RACIAL JUSTICE PRACTICES, INCLUDING TOOLS, BOOKS, REPORTS, ARTICLES, WEBSITES, VIDEOS, PODCASTS, AND CONSULTANTS. WE ALSO CONTINUED OUR BAHIP WORK - NPH PLACED THE 2020-2021 COHORT OF 11 INTERNS AT 11 HOST AGENCIES IN JUNE 2020 AND SUPPORTED THEIR YEAR-LONG PAID INTERNSHIP THROUGH MONTHLY COHORT TRAININGS, MENTORSHIP, AND LEADERSHIP DEVELOPMENT OPPORTUNITIES.
