Core Programs: PAN has campaign activities in four key agricultural states, as well as national and international programs. Our state campaigns in California, Hawaii, Iowa and Minnesota use coalition organizing, strategic communications and grassroots science to raise public awareness about pesticide harms and build momentum toward a healthier food and farming system. In 20202021, our successes included 1) launching a new Farm Policy Commons program to develop tools and resources for state policy advocacy outside our key states; 2) strengthening our coalition work in our key states with new staffing and partners, including an on-the-ground, Native Hawaiian staff member in Hawaii to support our coalition partners there; and 3) building momentum for international-level support for agroecology, and challenging corporate control of global policy spaces.

COALITIONS: PAN builds network power through strategic alliances with other organizations, particularly those whose members are on the frontlines of harm from chemical-intensive agriculture (e.g., farmworkers, rural families, community-scale farmers and Indigenous communities). Our campaign work often leads to creation of formal coalitions for which PAN acts as facilitator, administrator and/or fiscal sponsor. One of our fiscal sponsorees is Toxic Taters, a group which PAN helped create to organize around pesticide drift harms from potato production in Northern Minnesota. In 20202021, PAN worked to evaluate and improve our fiscal sponsorship program, conducting surveys of sponsorees and streamlining and clarifying internal processes. The team also identified ways to strengthen the program to help build sponsored capacity, and what resources would be needed to support such expansion.
