LEGAL: NCLR UNDERTOOK NEW LITIGATION, CHALLENGING FLORIDA’S AND KENTUCKY’S BANS ON ESSENTIAL MEDICAL CARE FOR TRANSGENDER YOUTH; CHALLENGING ARIZONA’S SPORTS BAN ON BEHALF OF TWO TRANSGENDER GIRLS; REPRESENTING A LESBIAN SPOUSE IN OKLAHOMA IN APPEALING A TRIAL COURT DECISION IN WHICH A JUDGE REFUSED TO APPLY THE PRESUMPTION THAT BOTH SPOUSES ARE LEGAL PARENTS OF A CHILD BORN DURING MARRIAGE AND INSTEAD RULED THE SPERM DONOR IS THE CHILD’S LEGAL PARENT.
