IN ADDITION, WE ARE PART OF A NETWORK OF LGBTQ IMMIGRANT ORGANIZATIONS THAT COMMUNICATE REGULARLY TO SHARE STRATEGIES AND STAY UPDATED ON ONGOING POLICY CHANGES. NCLR REMAINS COMMITTED TO OUR CLIENTS (80-100 CLIENTS SERVED ANNUALLY) AND THE LARGER LGBTQ IMMIGRANT COMMUNITY, (CONTINUED ON SCHEDULE O)RESPONDING TO 300-500 REQUESTS FOR LGBTQ IMMIGRATION RELATED INFORMATION EACH YEAR. THE CURRENT ADMINISTRATION SEEKS TO DEPORT 3,000 PEOPLE A DAY AND A TOTAL OF ONE MILLION PEOPLE PER YEAR. FOR THE APPROXIMATELY 288,000 UNDOCUMENTED LGBTQ IMMIGRANTS LIVING IN THIS COUNTRY, THE THREAT OF DEPORTATION IS ESPECIALLY CONCERNING. MANY OF OUR CLIENTS FLEE COUNTRIES WHERE BEING LGBTQ IS CRIMINALIZED AND SOMETIMES PUNISHABLE BY DEATH. DEPORTATION CAN BE A DEATH SENTENCE.

BORN PERFECT: IN MARCH OF 2025, THE SUPREME COURT OF THE UNITED STATES DECIDED TO TAKE UP A CHALLENGE TO THE TENTH CIRCUIT’S RULING UPHOLDING COLORADO’S LAW PROHIBITING CONVERSION THERAPY FOR MINORS.
