We fund civil rights, human rights, anti-poverty, and environmental justice cases that will affect a marginalized group. Most of our grants are for class actions, but we also fund multi-plaintiff and environmental justice cases that aim to significantly affect a larger system or lead to significant law reform. In the 2021/22 fiscal year, the Impact Fund disbursed a total of \$385,635 in grant funding via 24 recoverable grants. The Impact Fund has committed around \$8 million to justice-related causes since the organizations inception.
