Since its founding, the program has grownsignificantly and continues to certify the majority of the voluntary renewable energy transactions in the U.S., including renewable electricity from more than half of the U.S.s wind generation. Green-e Energys sister programs, Green-e Climate and Green-e Renewable Fuels Markets, provides consumer protection and quality assurance to the voluntary carbon offset market, and Green-e Marketplace supports businesses to use renewable energy and carbon reductions, and assists them in communicating their actions to internal and external stakeholders.

The Organizations policy outreach impacts regulators,legislators, policy implementers, and thought leaders locally and regionally in North America and globally and promotes the effective integration of policy and market solutions to advance sustainable energy. CRS launched the Clean Energy Accounting Project in 2020 to develop standardized clean energy and GHG emissions accounting guidance addressing outstanding questions in voluntary and regulatory markets.
