The Freedom Archives is crucial in documenting a history of social justice movements and making it a resource to contemporary movements. We repurpose archival materials in audio and video documentaries that shed light on subjugated histories. This year we completed a major project on the anniversary of the murder of George Jackson that included unique historical materials as well as new video interviews.

Interns: Our internship program encourages engagement with historical materials and provides media production training as well as fostering a love for progressive history. All interns complete an introductory orientation program which familiarizes young people with the language, policies and workflow of our archives and helps them identify potential topics of interest.
