IN 2020, CONSUMER WATCHDOG CAMPAIGN (CWC) CONDUCTED RESEARCH AND MONITORED THE IMPACT ON THE PUBLIC OF CONSUMER PROTECTION ISSUES, FOCUSING ON PATIENT SAFETY REFORM AND CIVIL JUSTICE. CWC SUPPORTED THE SIGNATURE-GATHERING CAMPAIGN FOR THE FAIRNESS FOR INJURED PATIENTS ACT, A CITIZEN INITIATIVE MEASURE THAT WOULD ADJUST THE \$250,000 CAP ON COMPENSATION FOR CALIFORNIA MEDICAL NEGLIGENCE VICTIMS FOR INFLATION, AND ALLOW JUDGES AND JURIES TO DECIDE FAIR COMPENSATION IN CASES INVOLVING CATASTROPHIC INJURIES OR DEATH. THE FAIRNESS ACT SUCCESSFULLY QUALIFIED FOR THE NOVEMBER 2022 CALIFORNIA BALLOT. CWC EDUCATED THE PUBLIC ABOUT HOW THE MALPRACTICE CAP CLOSES THE COURTROOM DOOR AND DENIES CALIFORNIA FAMILIES JUSTICE, AND ABOUT ITS DISPROPORTIONATE IMPACT ON WOMEN AND COMMUNITIES OF COLOR. CWC CONDUCTED APPROXIMATELY 30 VIDEO INTERVIEWS WITH INDIVIDUALS HARMED BY, AND THE FAMILY MEMBERS OF THOSE KILLED BY, MEDICAL NEGLIGENCE AND PRODUCED VIDEOS TO SHARE THEIR STORIES. CWC CONDUCTED OUTREACH TO TRADITIONAL MEDIA AND ON SOCIAL MEDIA, TO SHARE THE STORIES OF FAMILIES HARMED BY MEDICAL NEGLIGENCE ACROSS CALIFORNIA TO ILLUSTRATE THE NEED TO UPDATE THE CAP.
