IN 2021, CONSUMER WATCHDOG CAMPAIGN (CWC) ADVOCATED TO PASS THE FAIRNESS FOR INJURED PATIENTS ACT, A CITIZEN INITIATIVE MEASURE TO JUSTIFY THE \$250,000 CAP ON COMPENSATION FOR CALIFORNIA MEDICAL NEGLIGENCE VICTIMS FOR INFLATION, AND ALLOW JUDGES AND JURIES TO DECIDE FAIR COMPENSATION IN CASES INVOLVING CATASTROPHIC INJURIES OR DEATH. THE FAIRNESS ACT SUCCESSFULLY QUALIFIED FOR THE NOVEMBER 2022 CALIFORNIA BALLOT. CWC CONDUCTED OUTREACH ON SOCIAL MEDIA AND TO TRADITIONAL MEDIA, ISSUING NEWS RELEASES AND GENERATING STORIES ABOUT FAMILIES HARMED BY MEDICAL NEGLIGENCE ACROSS CALIFORNIA TO ILLUSTRATE THE NEED TO UPDATE THE CAP.
