Services include crisis intervention,; emergency assistance with food, rent, and utilities; emergency shelter coordination; employment assistance; and long-term counseling and support services.

4b (Code:) (Expenses \$ 726,075 including grants of \$) (Revenue \$ 93,066)

Senior Action program - TCAA provides resources to older adults and disabled members of the community to help them maintain their independence. TCAA operates four senior centers in Tempe and Scottsdale, Arizona. Services include addressing nutrition needs by providing meals (congregate and home-delivered) and nutrition education, senior center socialization and education services, transportation and outreach for seniors, senior peer counseling, social service assistance and home visits.

Health coalition - The collaborative health program assists vulnerable community members who have difficulty accessing needed health services and empowers them in their own health care. TCAA offers a variety of health promotion activities in Tempe and through community outreach. Services are focused on elderly community members, uninsured and under-insured birth Tempe children and families and pregnant women who are at-risk for poor birth outcomes. Services include health promotion workshops, fitness programs, health screenings and follow-up care, immunization clinics and parenting classes.




