THE PROGRAM ASSISTS SECOND GRADE STUDENTS ENROLLED IN BIRMINHGAM CITY SCHOOLS TO IMPROVE THEIR READING SKILLS. STAIR IS AN AFTER SCHOOL PROGRAM USING AROUND 350 VOLUNTEER TURORS WHO TEACH ONE-ON-ONE READING LESSONS TO AT-RISK CHILDREN WHO ARE CHOSEN BY THEIR TEACHERS. IN THE 2015 - 2016 TAX YEAR, THERE WERE 11 SITES THOUGHOUT BIRMINHGHAM WHICH SERVED OVER 170 STUDENTS. STUDENTS MET TUTORS TWICE A WEEK FOR 2 HOURS, SEPTEMBER - APRIL. STUDENTS ARE TAUGHT A VARIETY OF SKILLS NECESSARY TO READ AT GRADE LEVEL. THE EFFECTIVENESS OF THE PROGRAM IS MEASURED BY THE STANDARIZED TEST GIVEN BY THE SCHOOL. STUDENTS WHO COMPLETE THE STAIR PROGRAM CONSISTENTLY SHOW AN AVERAGE RATE OF IMPROVEMENT OF OVER 90% IN READING FLUENCY.
