## Director's Corner: How Can You Miss Me When I Won't Go Away?

I was changing the car radio station as we approached Sacramento last weekend when the dial landed on Dan Hicks and the Hot Licks singing, "How Can I Miss You

When You Won't Go Away?" I turned the volume up. My husband looked over at me and laughed. That old song suddenly struck a new chord.

I said goodbye to all of you in my last Director's Corner, but it's time for another issue of The Works and I'm still here. Please let me explain. I will stay until JobTrain's next Executive Director is ready to take over. The search is lasting a little longer than expected, but it's a big step and the board knows it is worth doing right. Unexpectedly, I am enjoying JobTrain from a different perspective.

I feel more and more like the central character, Emily, in Thornton Wilder's classic play, "Our Town". In the play, Emily observes after her death that we humans go through life without really savoring it, without fully experiencing everyday moments and relationships. The limited time I have left to be part of day-today life at JobTrain intensifies my appreciation of its uniqueness: motivation sessions, the ringing job bell, banging hammers and grinding concrete, blood pressure clinics, the aroma of world-class dishes created by chefs-in-training. And I cherish more than ever the hope and determination I see in our trainees' faces.

Daily life at JobTrain is a kaleidoscope of brilliant moments: triumph and disappointment, epiphany and practical progression, and even life and death. A few weeks ago, a Culinary Arts student was shot and killed in East Palo Alto. A wave of shock and sadness swept through JobTrain. Our flag flew at half-mast. The entire Culinary Arts class attended funeral services. But during that same week, new students started their training and others landed their dream jobs. The rhythm and heartbeat of JobTrain is sometimes interrupted, but it never stops. JobTrain is strong. JobTrain is resilient. JobTrain is on the right track.

## **Building Trades Classes Move To Main Training Facility**





If you hear the rat-a-tat-tat of a jack hammer and the beep-beep of large equipment vehicles, you just might be at JobTrain. The Building Trades classes moved from the Annex to the main training facility at 1200 O'Brien Drive in Menlo Park, and those are the new sounds that emerge from our back-parking-lot-work area. JobTrain is bursting at the seams with more students and training activity than ever. Nearly 50 more students are on campus now, donning hardhats and carpenters overalls, and adding to JobTrain's positive energy. All three courses – Project Build (carpenters), Laborers Pre-Apprenticeship and Solar – utilize both classroom and outdoor work space for their training. The laborers class recently added a new component in Spanish.

# JobTrain Partners with Ravenswood To Launch School Bus Driver Training

JobTrain is happy to announce that a new short-program to train school bus drivers will launch in July. The School Bus Driver program is a 60-80 hour course that will qualify graduates to drive school buses, city buses, shuttles, taxis and other public transport vehicles. The training is offered in partnership with Ravenswood City School District. Half the course will take place at JobTrain and will consist of safety, CPR and protocol training. The other half of the class will be behind-the-wheel training at Ravenswood City School District.

Enrollees in the course must have clean driving records, no history of convictions, and must pass a medical examination. School bus drivers earn between \$16.00-\$27.00/hr. The San Mateo County Labor Market Information Index projects a 25% increase in demand for these jobs by 2020.


## **Trainee of the Month Winners Overcame Challenges**

Guadalupe Lara is a single mother of two boys. She is a hard working and reliable student in JobTrain's Medical Office Assistant APRIL 2013 class. Both of her children have serious medical problems, but Lupe manages the delicate balancing act of caring for the boys, meeting her classroom obligations at JobTrain, and progressing toward her goal of a better life for

she can help others. Lupe was recognized for her selflessness, determination and quiet

strength. She will make an excellent employee in the healthcare or social services field.

Mental Health Services Offered Onsite at JobTrain

For years, JobTrain teachers and counselors have been hoping to find a resource for onsite mental health services. Finally, as part of a grant agreement with Tipping Point and Stanford University, JobTrain will have a part time MFT (Marriage and Family Therapist) intern on site to provide therapeutic counseling services. Dr. Daryn Reicherter of Stanford University is heading this project with Drs. Rebecca Rialon Berry and John Rettger. This is a ground breaking collaboration, with no known precedence for mental health services in a non-clinical environment. JobTrain clients will have the opportunity to meet one on one with a qualified clinician and will have Stanford doctors available for referral. Staff will have self-care resources available, and will be trained on topics including stress reduction and coping techniques.

## Free Tax Prep Returns \$1 Million to Families

Did you know that JobTrain offers free tax services to local low income residents? In its fourth successful year at JobTrain, the tax program helped more than 800 people file their 2012 state and federal tax returns, resulting in more than \$1 million dollars in refunds. The program works because of a solid partnership with Tax-Aid and Single Stop USA. Tax-Aid recruits and trains volunteers to prepare individual state and federal tax returns, business taxes (Schedule C), immigrants filing ITIN, prior year returns, and early IRA distributions.

More than 2,200 tax returns have been filed since JobTrain began the tax program in 2010, bringing over \$3 million dollars back to our community in the form of tax refunds. Our partner, Single Stop USA, brought the program to JobTrain.

#### **Computer Service Technician class**

- Hubs/switches and cables for classroom network. Need to hook up 10 computers to Computers for Everyone's rooftop antenna for Internet exercises, Windows Updates, driver searches, and network printers.
- Tablet, smartphone using Android or iOS operating systems. For demonstration of mobile functions.
