Dear Reader of dZi Foundation Financial Documents,

For starters, thank you very much for your interest in dZi Foundation! One of our core values is Financial Transparency. One way we express this publically is by openly providing our 990 tax information and our audited and/or reviewed financial statements online.

We usually let these documents speak for themselves, but for this fiscal period I thought it would be important to include some clarifying information:

- dZi Foundation changed its fiscal year from the traditional calendar year (January 1--December 31) to July 1—June 30 **as of July 1, 2015**. We did this to better align with the fiscal calendar and the construction season in Nepal (which is dictated by annual monsoon rains). In this way we can serve our partner communities even more effectively in the future.
- Therefore, the 990 and Audited Financial Statements for this period are for a unique transition period between our old and new fiscal years, namely the **six-month period** from January 1—June 30, 2015.
- We have chosen to be audited by Gelman, Rosenberg and Freedman. Based just outside of Washington DC, this firm is well established and respected as a leader in international non-profit accounting. You may not know that the state of Colorado does not require non-profit organizations to be audited regardless of the level of fundraising activity! We choose to be audited because it is the right thing to do, and it makes us a better organization.
- For those of you reading the 990, please note that because this is a fiscal period that is shorter than one full year, the IRS rule is that zero (0) employees are recorded in Part 1, Line 5. This is a bit confusing, but apparently such is the rule!
- For those of you interested in Functional Expense Ratios, you can find those broken down in the Financial Statements on page 6 and in the 990 on page 10, Line 25.
- Our current fiscal cycle ends June 30, 2016. Shortly thereafter, we will file our 990 taxes and have our financials audited for the full fiscal year July 1, 2015 – June 30, 2016.

You will find our financial information in the pages that follow. Thank you again for your interest in dZi Foundation.
