The year of 2015 was a year of transition for the Friends of Front Street Shelter. In order to prepare the Friends to increase membership and shift to a model of a more proactive approach to fundraising, the board filed with the various agencies to officially change the name from Friends of the Sacramento City Shelter Animals to Friends of Front Street.

The Sacramento Region Community Foundation selected Friends as one of only a handful of nonprofits invited to participate in person during the Big Day of Giving at Cesar Chavez Park. Board members Rosemary Lamb and Kirsten DuBray spent the day at the park helping to engage the community in the Shelter and raise additional funds for Friends. In addition, board members spent several days calling donors from the 2014 Big Day of Giving to help increase support. Ultimately \$49,000 was received to benefit the Shelter.

One of the most successful community outreach activities was the Beer Garden events. Income from these summer events totaled \$103,000 and helped to broaden the Shelter's reach in a fun and engaging way.

For the fourth year the very successful gala event Paws to Party took place in September and raised the most money to date with Friends receiving \$13,260 from the proceeds.
