GRANTMAKING: We made over 500 small grants of \$500-\$5000 to social change projects all over the world, helping them launch grassroots initiatives that expand compassion in communities worldwide. We provide funding to projects that create a more peaceful, just, spiritually fulfilling and environmentally sustainable human presence on the planet. We also operated grant-making programs specifically focused on: 1) Youth environmentalism around the world, 2) Youth leadership in the US, 3) Youth-led social change projects in California, and 4) a series of grants aimed to support social change community leaders in Uganda and Kenya and 5) Leaders in the global animal advocacy movement.

GRANTEE SERVICES: We offered an array of "value added" support to grantee projects, including: online capacity building and leadership trainings, in person grantee meetings and retreats, promotional and media support, coaching, mentoring and networking opportunities. Our grantees report that the additional services we offer is what make\$ our grants so much more valuable than the dollars we give.

PHILANTHROPY: We supported the development of the philanthropy sector by presenting at conferences, writing articles and participating in philanthropic networks.
