A typical grant is \$1000. We have special grant making programs emphasizing: 1) programs led by young people ages 14-24; 2) programs that are working in Uganda and Kenya; 3) programs that support youth leadership around the US; and 4) programs that advocate for animals around the world.

PHILANTHROPY: We provide venues to share information about our decentralized approach to making small grants on a global scale. This includes writing, video materials and events.

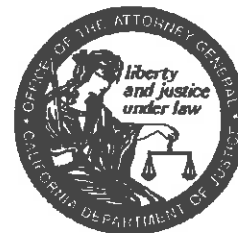
