Foundation accounts for tax uncertainties based on a more likely than not recognition

threshold whereby tax benefits are only recognized when the Foundation believes that they

have a greater than 50% likelihood of being sustained upon examination by taxing

authorities. The Foundation has evaluated all its tax positions and determined that it had

no uncertain income tax positions as of December 31, 2013 or 2012. The Foundation believes

it is no longer subject to income tax examinations for years prior to December 31, 2010.
