LOCATED IN THE INNER-CITY OF DOWNTOWN LEXINGTON, KENTUCKY THE LASC IS LOCATED IN A HISTORIC BUILDING, THE KINKEAD HOUSE, WHICH WAS BUILT IN 1847 BY ABRAHAM LINCOLN'S ATTORNEY, GEORGE KINKEAD. IN 1970, DESCENDANTS OF THE KINKEADS' LOANED THE HOUSE TO THE LASC TO USE FOR PROGRAMS AND IN 1981, THE KINKEAD FAMILY DONATED THE BUILDING AND GROUNDS TO THE ORGANIZATION. LASC OPENED THE LUCILLE CAUDILL LITTLE DISCOVERY CENTER, AN 11,000 SQUARE FOOT ADDITION TO THE HISTORIC KINKEAD HOUSE IN 2016.
