In 2022, the Institute presented 12 multi-day leadership programs serving 138 people. Two programs were delivered in person with the remainder delivered online. Eleven of the programs were open enrollment. Thirteen attendees were supported on partial scholarships totalling nearly \$4000. Additionally, IZL faculty presented at 8 other programs and online summits and conferences with thousands of attendees. The Institute's President continued to raise visibility of IZL's programs as a regular contributor to Forbes.com with a reach of tens of thousands.

4b (Code:) (Expenses \$ 71,671 including grants of \$ 22,604) (Revenue \$ 100,000)

We planned and successfully applied for grants to host a global online summit: One Earth, One Health, One With - a leadership summit for people, planet and the future. The purpose of the summit is to explore the impacts of climate change on health, help leaders find what they can do to create more healing in these times, and be resourced to do the work. The summit runs April 20-26, 2023.

The FEBI mind-body personality instrument was used throughout our programs, and our FEBI Operations Manager supported over 200 certified coaches. In addition, 17 new coaches were certified and we launched a new introductory program called FEBI-4U. An upgrade to the FEBI platform was completed and launched in early 2022.
