We focus on young men aged 12-17 with an emphasis on middle school boys, as this is traditionally a time when boys are still impressionable and open to new ideas. Mentors help young men figure out what kind of an adult man he wants to be, praise him for his gifts, support him when he makes mistakes, and encourage him to make good choices on his path to manhood. The desire is for this to be learned from a positive role model verses someone on the street corner.
