THE PROGRAM TARGETS GAY MEN OF COLOR WHO ENGAGE IN HIGH RISK BEHAVIORS THAT PLACE THEM AT RISK FOR HIV INFECTION OR TRANSMISSION AND INDIVIDUALS ARE RECRUITED AND THEN TAKEN ON AN ALL EXPENSE PAID 2 DAY RETREAT WHERE THE INTERVENTION IS COMPLETED.

WE DID OUTREACH TO OVER 3,600 CLIENTS AND 60 COMPLETE THE INTERVENTION WHICH WAS THE TARGET NUMBER FOR THE YEAR.
