THE MAJORITY OF THOSE SERVED ARE CONSIDERED ECONOMICALLY DISADVANTAGED BY FEDERAL MEASURES. THE DCP CONTRACTS WITH YMCA OF METROPOLITAN DETROIT TO ADMINISTER THE IMPROV PROJECT AT SEVERAL SCHOOLS AND NON-PROFIT SERVICE ORGANIZATIONS. MOST OF THESE PROGRAMS WERE OFFERED AT NO CHARGE.
