By doing so, this allows us to add more events to meet the large demand for our programming. We added 17 Kindful Leaders in 2016, which allowed us to create another 17 monthly volunteer experiences. With an average of 12 volunteers per event, that is another 204 people served per month, or 2448 per year.

4b (Code:) (Expenses \$ 16,398 including grants of \$) (Revenue \$ 10,246) Project Helping has developed an online platform called KyndHub to keep our volunteers connected socially, and to give them access to more volunteer experiences. This program also allows us to reach individuals around the country and would with our mission. As KyndHub grows, it will also create financial resources for Project Helping to grow its mission through corporate usage. This program futhers our mission by making it more accessible and also creates revenue.

This program makes volunteering accessible for families and children of any age. It teaches familites arbout Kindfulness and how to practice it together to imporve their mental wellness. This program did not incur cost in 2016.
