CHARLES, LINCOLN AND WARREN COUNTIES. WE ARE ONE OF TWENTY-TWO CENTERS IN MISSOURI. CENTERS FOR INDEPENDENT LIVING AROSE FROM THE DISABILITY RIGHTS MOVEMENT OF THE EARLY 1970S. COMMUNITIES WERE NOT ACCESSIBLE AND SUPPORTS TO ASSIST PEOPLE WITH REMAINING IN THEIR HOMES DID NOT EXIST.
