Garden City Community Clinic-provides charity medical and dental services to lower income, uninsured patients by using volunteer health professionals. During FY, 3015 patient encounters were provided. Expenses here does not reflect \$205256 of donated services by 165 volunteers; plus another \$84,073 in outside professional services.

Volunteer Physicians Network-provides charity specialist physician referrals for patients of three Ada County safety net health clinics. During the FY, 611 lower-income unsured patients were served through 1422 appointments for a total of \$1.3 million worth of services.

Genesis International-provides support to development and support of long-term sustainable projects. The PEFA Mercy Medical Center in Kenya provided more than 12,000 patient encounters during the year. A dental clinic was furnished at the same facility. Investigation trips were taken to Rwanda and Kenya.
