4a (Code:) (Expenses \$ 733,814 including grants of \$) (Revenue \$) Genesis Community Health provided a total of 5,669 charity medical, dental, mental health counseling, community health consultations, medication assistance, and specialty care coordination to low-income uninsured individuals and families. These services were provided by approximately 200 volunteer health professionals and non-professionals. The breakdown of services is: Medical, 1,599; Dental, 815; Counseling, 412; Community Health, 1,533; Medication Assistance, 680; and Specialty Coordination, 630. Additionally, prescriptions filled were 2,396 valued at \$65,160. These numbers are lower than previous years due primarily to the impact of the COVID-19 pandemic.
