AMENDMENTS TO FRIENDSHIP HOME ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of 21 years or more, acting as incorporators of a corporation under the Nebraska Non-profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation shall be FRIENDSHIP HOME OF LINCOLN.

ARTICLE II.

The period of its duration shall be perpetual.

ARTICLE III.

The name of the corporation shall be FRIENDSHIP HOME OF LINCOLN.

The Corporation is organized for the purpose of:

- (a) Providing shelter and related services as provided in the Bylaws.
- (b) The acquisition, maintenance, preservation and disposition of property, real and personal, used and useful for carrying out the purposes heretofore set forth.
- (c) Having and exercising all the powers and privileges of a non-profit corporation under the provisions of the act known as the Nebraska non-Profit Corporation Act, Sections 21-1901 to 21-19,109, 1991 1977 Reissue Revised Statutes of Nebraska, 1943.

ARTICLE IV.

Provisions for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation are:

- (a) This corporation is organized and shall operate exclusively for those purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of the United States or any amendment thereto or law adopted in place thereof. No part of its income or main earnings shall inure to the benefit of or distribution to any director, officer, or individual.
- (b) In the event of the liquidation or dissolution of this corporation, whether voluntary or involuntary, the balance of all money and other property received by the corporation

from any source, after the payment of all debts and obligations of the corporation, shall be used or distributed within the intendment of Section 501 (c)(3) of the Internal Revenue Code of 1954 1986 and the regulations thereunder as the same now exist, or as they may be hereafter amended from time to time.

- (c) The affairs of the corporation shall be managed by a Board of not less than five (5) nine (9) Directors.
- (d) The governing body of the corporation, the Board of Directors shall be elected and entitled to vote, as provided in the Bylaws.
- (e) The corporation shall have officers as provided by the Bylaws.
- (f) There may be such committees as shall be appointed by the Board of Directors as may be specified in the Bylaws.
- (g) No committee shall exercise those powers prohibited to a committee of this corporation by the provisions of Section 21-1904, R.R.S., Nebraska, 1943, et seq.
- (h) The corporation may adopt such Bylaws as are necessary or desirable to implement the provisions of the Articles of Incorporation.
