Turner House Children's Clinic provides high quality pediatric primary health care services to uninsured and underserved children 0-18 including baby and well-child examinations; acute and chronic care, developmental screenings; hearing and vision screenings, immunizations, laboratory tests, lead tests, asthma education and management, medications and referrals to medical specialists. More than 4,100 children were seen in approximately 8,200 patient visits. In addition to staff pediatricians, more than 20 volunteer physicians and nurse practitioners provided almost 800 hours of care valued at \$60,000. All children age 0-3 are seen by a Healthy Steps Specialist who provides developmental screenings and parent education to help children reach developmental milestones. The clinic also participates in the Reach Out and Read program, which promotes early literacy with children 6 months to age 5. A total of 16 volunteers read to children in the waiting room and provided new books to children. Patients are accepted regardless of their ability to pay. All Spanish speaking families have access to bilingual staff.
