



During the next three decades, the organization evolved from a volunteer pediatric clinic to a paid-provider practice and achieved national recognition as a Patient-Centered Medical Home, providing integrated primary medical, behavioral health and dental services for all.

Dental caries (cavities) are rampant in Turner House patients, many of them have received no preventative oral hygiene care. As a result, Turner House provides a portable dental hygiene program to area schools and in-clinic.

74% of patients lived below 200% of the Federal Poverty Level and approximately 82% of visits were provided to patients living at or below the 200% of the Federal Poverty Level. Vibrant Health achieved a 23% increase in patients (10,130) and a 13% increase in visits (27,374) compared to 2018; 32% of patients last year were new, first time patients. To better meet the needs of patient families, we expanded weekday clinic hours to include more start times before 8 am and more clinic hours after 5 pm in addition to Saturday clinic sessions.
