Design Outreach (DO) is a Christian humanitarian engineering nonprofit organization dedicated to creating life-sustaining technology that alleviates global poverty. DO focuses on innovative products that improve the lives of the most marginalized and vulnerable people living in rural communities in developing countries. DO's flagship technology, LifePump™, has been installed in 10 countries, bringing safe and reliable water to approximately 60,000 people globally. The first permanent LifePump was installed in 2013 and has been operating since then with zero days of downtime. LifePump is designed to operate deeper in the ground and last longer than traditional hand pumps, providing safe and reliable water access in communities where other technologies have been unable to meet their needs. In 2019 and 2020, LifePump caught the attention of government officials in Zambia and Malawi, where the technology became recognized as a national standard for hand pumps. While DO is working to develop and deploy other appropriate technologies for developing countries in sectors such as WASH, medical devices and agriculture, LifePump has remained the organization's core focus as national governments have begun to recognize its potential to help address water poverty in rural communities. In 2020-despite the global pandemic-DO manufactured 100 LifePumps, with shipments to Kenya, (Continued on Schedule O, Statement 1)

Another key program DO focused on in 2020 was the establishment of its first international field office known as the Malawi Field Office, located in the country's capital city of Lilongwe. This facility will act as an advocacy hub and field innovation center while providing warehouse space for LifePumps, spare parts, the Training of Trainers program, and rapid response teams. In 2020, DO established office space, hired two full-time employees, started preparing a guest house, and purchased a shipping container and vehicle for use in the field. Through this new international operation, DO will be more readily available to visit LifePump communities for follow-up assessments on impact and functionality over time. Such follow-up will aid further research and development efforts as well as associated tool and maintenance strategies. The Malawi Field Office also supports in-person advocacy efforts as DO will be more available to meet with missionaries, NGOs, community leaders, and government officials on a regular basis. In addition, the Malawi Field Office supports the organization's Training of Trainers program, which will equip local leaders with the tools and knowledge they need to keep their LifePumps up and running for decades to come. As governments continue to recognize LifePump as a game-changer in the water sector, the Malawi Field Office will enable DO to continue building (Continued on Schedule O, Statement 2)

In 2020, Design Outreach engineering teams worked on seven research and development (R&D) programs and engaged over 60 volunteer engineers, designers, and project managers. The volunteers work in teams alongside DO's five R&D staff members. Because of this enormous workforce with a singular focus on appropriate technology development, the DO team made excellent progress on continuously improving our core technologies while also working on new developments in appropriate technology. Projects related to LifePump and LifePumpLink focused on reducing costs without compromising quality, preparing for mass production, and gathering and presenting remote monitor data in new ways to our field partners. For example, the following accomplishments were completed for LifePump and LifePumpLink in 2020: implemented upgraded component design, validated progressive cavity pump (PCP) manufacturing change, developed quality test methods for critical components, completed experimental testing on new component concepts, updated production documents and training materials, and launched new LifePumpLink data dashboard and mobile app (beta version). Zimbabwe, Zambia, Malawi, and Guatemala. DO also installed 25 LifePumps and recorded critical data from 51 LifePumpLinks, a remote satellite monitor designed to provide LifePump data, such as handle rotations and gallons pumped, in real time. From those 51 LifePumpLinks, DO measured more than 338 million LifePump rotations and estimated that 27 million liters (6 million gallons) of water were pumped in 2020. Currently, 105 LifePumps are in transit and ready to be installed. As part of DO's LifePump program in 2020, a year dramatically impacted by the global COVID-19 pandemic, the organization focused on providing COVID-19 prevention resources and supplies through its HandWASHing for ALL campaign. Through this program, DO not only continued to provide LifePumps and LifePumpLinks but also distributed supplies such as face masks, soap, Bibles, and WASH hygiene training to 71 communities in Zimbabwe, Malawi and Zambia, impacting an estimated 42,500 people. In these communities, a total of 19,543 face masks, 19,931 tablets of soap, and 425 Bibles were distributed. (Please note: Due to COVID-19 activity in these communities late in 2020, some of these supplies were delayed and distributed in early 2021.) This program also promoted informative community gatherings and equipped volunteers with materials to make visits to households to continue educating people on proper mask wearing, handwashing techniques, social distancing, and sharing the Gospel. In the communities where these visits and gatherings occurred, community headmen, government health officials, church leaders, and local journalists were often in attendance. The COVID-19 prevention trainings equipped community leaders with appropriate knowledge and skills on COVID-19 health-related issues and management, which they would further cascade to small groups in their respective communities. The trainings were facilitated by health experts in hospital COVID-19 response. Key messages during these meetings were correct wearing of masks, thorough and frequent handwashing, and social distancing in their communities. In many of these communities, which are miles from the nearest market, families had no way of accessing face masks, soap or Bibles, and DO's outreach was the one chance they had to receive the peace of mind that comes with these infection-prevention tools and resources. Through collaboration with ministry partners, this program also involved Gospel presentations in many of the communities. These gatherings included worship music, dancing, teaching, and Bible distribution. Each meeting drew anywhere from 100 to 1,000 people.

For both projects, the DO team completed the 'inspiration' phase, which provides background research to appropriately define the engineering problem and requirements. In addition, the Hands-free LifeTap project team created functional prototype that were reviewed with implementing partners. Global health is a new area of focus for Design Outreach. In 2020, Design Outreach partnered with the Ohio State University engineering capstone teams in researching and developing appropriate technologies such as the oxygen concentrator humidifier bottle and low-cost wound vacuum pump that center on helping remote hospitals overcome the challenge of disposable products in a weak supply chain environment by providing affordable and reusable products as well as solutions for infection control. Each of these projects means helping thousands of people today and millions in the future.
