In the year ended 09/30/14, HITS enrolled almost 950 students in one or more of its classes and workshops, with classes at 95% - plus capacity. A portion of students receive needs-based full or partial tuition scholarships. HITS serves the entire Houston Metropolitan region with registered students from 60 zip codes and from as far away as Montgomery, Pearland, Baytown, League City, Missouri City, Cypress, Spring, Stafford, Friendswood and Katy. Since its inception, approximately 512,000 children and adults have been educated and entertained through HITS Theatre Classes and free community performances.
