In the year ended 09/30/13, HITS presented 6 free performances of Thoroughly Modern Millie at Houston's Miller Outdoor Theatre. This production, which was seen by almost 30,000 Houstonians, featured 50 performers all under the age of 19. Additionally, HITS enrolled almost 1,000 students in one or more of its classes and workshops, with classes at 95% - plus capacity. A portion of students receive needs-based full or partial tuition scholarships. HITS serves the entire Houston Metropolitan region with registered students from 40 zip codes and from as far away as Pearland, Baytown, The Woodlands and Katy. Since its inception, approximately 511,000 children and adults have been educated and entertained through HITS Theatre Classes and free community performances.
