In the year ended 09/30/21, HITS enrolled approximately 1,000 students in its classes and workshops, with classes and workshops impacted by the pandemic. We returned to Miller Outdoor Theatre for a weekend performance. In addition, some students receive needs-based full or partial tuition scholarships. HITS serves the Houston Metropolitan region with registered students from dozens of zip codes. Since our inception, approximately 634,000 children and adults have been educated and entertained through HITS Theatre Classes and free community performances.
