In the year ended 09/30/20, HITS enrolled approximately 500 students in its classes and workshops, with classes and workshops significantly impacted by the pandemic. The pandemic and local stay-at-home orders forced cancellation of programs in March 2020. In addition, our most significant performances scheduled for April 2020 at Miller Outdoor Theatre were canceled when the city shut down the venue where we traditionally perform these shows. Immediately, we shifted our resources to online offerings, which included many with no costs to participants. In addition, a portion of students receive needs-based full or partial tuition scholarships. HITS serves the entire Houston Metropolitan region with registered students from dozens of zip codes. Since our inception, approximately 624,000 children and adults have been educated and entertained through HITS Theatre Classes and free community performances.
