Women in Film & Video (WIFV) provided more than 60 programs during the 2012-13 program year to satisfy the PROFESSIONAL DEVELOPMENT and GENERAL EDUCATION needs of its 1000+ members. Most members attend multiple events per program year. All WIFV programs are open to the general public and we had more than 900 non-members attend the Wednesday Ones, Roundtables, ScriptDC and Media Job Fair. The meetings present industry leaders who share their insights and provide attendees with info to hone their skills to become better freelancers, employers and employees. In 2014 WIFV began its Spotlight on Screenwriters program to collect highly-scored screenplays and present them to producers across the country. WIFV nominates films annually for inclusion into the National Film Registry. WIFV continues its fiscal sponsorship program to support women-created documentary films and added new projects to that program.

Women in Film & Video (WIFV) offers NETWORKING opportunities at all events and provided several events to aid members in making connections across the Mid-Atlantic media industry. WIFV hosted a Fall Open House, Holiday Open House and more informal events for rising professionals to provide opportunities for more than 1000 new and existing members to network with each other and non-members. The Annual WIFV Media Job Fair involved more than 300 job seekers with 20 media companies.

Women in Film & Video (WIFV) distributed a member E-NEWSLETTER 24 times for it's 1000+ members. The e-newsletter promotes member accomplishments, introduces new opportunities and research, and informs WIFV Members about professional development and educational offerings from WIFV and other media organizations. The e-newsletter is archived on the WIFV website for general public access. The e-newsletter has dramatically increased the amount of information it presents because of the electronic format and now includes live links to information and members profiled making the material even more accessible via search engines.
