AT THE END OF 2021, 59 THP EPICENTERS HAD DECLARED SELF-RELIANCE, MEANING OVER 975,000 OF ITS COMMUNITY PARTNERS ARE NOW LIVING IN A SELF-RELIANT COMMUNITY WHERE THEY HAVE THE CONFIDENCE, CAPACITY, AND SKILLS TO ACT AS AGENTS OF THEIR OWN DEVELOPMENT. THE WORK THAT BEGAN IN PARTNERSHIP WITH THE HUNGER PROJECT IS NOW THEIR OWN, COMPLETE WITH GOAL-SETTING AND MEASURES OF THEIR OWN SUCCESS AND SUSTAINABILITY.
