GALLANTFEW (FORMERLY VETERAN MENTORING): GallantFew initiates all veteran services through a unique process called the GallantFew Azimuth Check (GAC). The GAC provides a self-assessment of the veteran's level of fitness in five areas: Emotional, Physical, Spiritual, Professional, and Social. Using this self-assessment, GallantFew veteran support specialists coach the veteran through an intentional process to improve levels of fitness the veteran identifies as needing improvement.

RUN RANGER RUN: 2020 was the last year GallantFew's annual fundraising and awareness event was called Run Rangers Run. Going forward, it is the more inclusive Patriot Challenge. GallantFew's Run Ranger Run is a wellness and fitness initiative during the month of February. Registered participants join a team and pledge to complete an average of two miles of physical activity every day during the month. Some corporations have adopted Run Ranger Run as a wellness initiative. Participants share GallantFew messaging on improving emotional, physical, spiritual, professional, and social fitness, and encourage veterans to join the GallantFew network. In a new aspect of Run Ranger Run, GallantFew partnered with two Ranger veteran organizations and granted a portion of the funds raised back to those participating organizations.

RAIDER PROJECT: The Raider Project is a focused effort on the Marine Corps Special Operations (Raiders) community. In September 2020, GallantFew helped the Raider Project launch into a standalone nonprofit. The Raider Project provided 448 services to Marine Corps veterans in 2020.
