In 2016, Children's Rights (CR) settled its case in South Carolina, helping to put in place measures that promise vital changes including reasonable caseloads, improved abuse investigations and revamped health care for foster youth. In Texas, a federal judge who ruled in favor of CR's plaintiff children appointed two Special Masters to oversee reform of the state's broken foster care system. In Georgia, thanks to substantial improvements in Metro Atlanta foster care, the state and CR agreed to a streamlined foster care reform plan that could put it on the path to exit court oversight. CR also helped secure Special Immigrant Juvenile Status for several unaccompanied minors who fled dangerous and violent situations in Central America.
