Farm and Garden - We helped start the Michigan Flower Growers' Cooperative at the Ypsilanti Farmers MarketPlace. Growing Hope grows and sells local organic flowers through this cooperative. We installed new raised bed gardens in six Habitat for Humanity households. We spent the majority of the season re-engaging 38 households, 86 people, that had previously received a raised bed garden from us through distributing free seeds and seedlings.

Farmers Markets - Growing Hope completed renovations on their new Ypsilanti Farmers MarketPlace. The MarketPlace is year-round indoor/outdoor Farmers Market in downtown Ypsilanti. It also holds their new licenced incubator kitchen. Growing Hope also use this space to hold community events and health and wellness programming. Growing Hope served 474 customers through our Ypsilanti Mobile Farm Stand. Growing Hope partnered with a lower-income Ypsilanti neighborhood association and a low-income senior residence to distribute and sell fresh, local produce.

Youth & Schools - Through our work starting and facilitating the Ypsilanti Community School district's Farm to School committee, we helped obtain funding for the school district to hire their first School Garden Coordinator. This position helps organize and maintain school gardens and supports more local food in Ypsilanti school cafeterias. We reached 376 Ypsilanti youth through our gardening and healthy eating "Seed2Plate" after school, summer camp and field trip programs. These students were introduced to new fruits and vegetables and learned how food is grown in a garden
