THE CENTER FOCUSES ON FEDERAL AND STATE AGENCIES RESPONSIBLE FOR MEDICARE, MEDICAID, SOCIAL SECURITY AND SSI -- PROGRAMS THAT LOW-INCOME SENIORS DEPEND UPON. THE CENTER'S LAWSUIT AGAINST THE SOCIAL SECURITY ADMINISTRATION RESTORED \$700 MILLION IN SOCIAL SECURITY AND SSI BENEFITS TO MORE THAN 200,000 PEOPLE. THE BI-WEEKLY WASHINGTON REPORT REPORTS ON NEW LEGAL AND REGULATORY DEVELOPMENTS AFFECTING OLDER AMERICANS, INCLUDING COURT CASES. THE BI-MONTHLY LONG-TERM CARE REPORTER REPORTED ON LEGAL NEWS AFFECTING CONSUMERS IN THE NURSING HOME INDUSTRY. THE LONG-TERM CARE REPORTER WAS DISCONTINUED IN FEBRUARY, 2010.
