Positively Trans

Positively Trans (T+) is a response to the structural inequalities that drive the high rate of

HIV/AIDS and poor health outcomes for transgender people. By partnering with a National

Advisory Board of community leaders, T+ seeks to mobilize and promote resilience of trans

people most impacted by or living with HIV/AIDS, particularly trans women of color, through

research, policy advocacy, legal advocacy, and leadership strengthening. In its first year, T+

has increased the presence of transgender advocates at key HIV conferences and meetings,

trained 150 healthcare providers and advocates at the AIDS United Access to Health Summit, and

developed and launched a needs assessment survey in English and Spanish to examine the legal

and policy landscape (results published in 2016).

California Public Education Campaign

In 2015, TLC launched Transform California, together with EQCA and a diverse coalition of

Californians who are committed to making the Golden State a place where all transgender people

can feel safe and live free from discrimination. The mission of Transform California is to

promote respect, understanding and safety for the transgender and gender nonconforming

community, and to oppose discrimination of all kinds. Transform California's key strategies

include messaging research, video storytelling, spokesperson training, coalition building,
