GLOUCESTER MATHEWS CARE CLINIC'S THREE MAJOR PROGRAMS ARE OUR MEDICAL CLINIC, DENTAL CLINIC AND PHARMACY, AND THESE SERVICES ARE PROVIDED TO UNINSURED PATIENTS AS WELL AS THOSE WITH MEDICAID THROUGH THE 2019 MEDICAID EXPANSION. OUR OVERARCHING GOAL IS TO PROVIDE EXCELLENT, COMPASSIONATE CARE, ENGAGING PATIENTS AS ACTIVE PARTICIPANTS WITH US IN MANAGING THEIR HEALTH CONDITIONS, ULTIMATELY IMPROVING THEIR QUALITY OF LIFE. DURING THE YEAR, WE SERVED 384 PATIENTS WITH 1,620 MEDICAL CARE VISITS, AND 42 DENTAL CARE VISITS. GMCC WAS ABLE TO PROVIDE 7,690 PRESCRIPTIONS FOR ITS CLIENTS. ALSO, OUR VOLUNTEERS PROVIDED 448 DONATED PHYSICIAN, NURSING, DENTIST AND PHARMACY AND OTHER HOURS TO OUR CLIENTS. 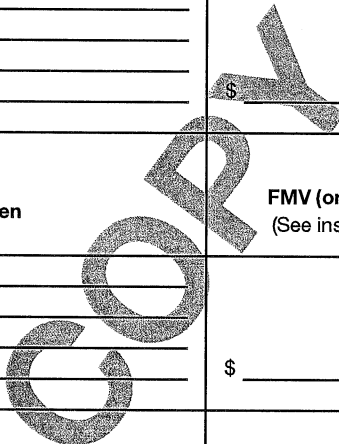

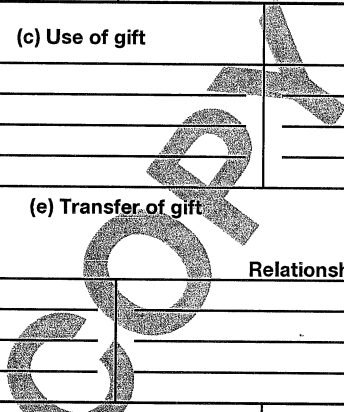

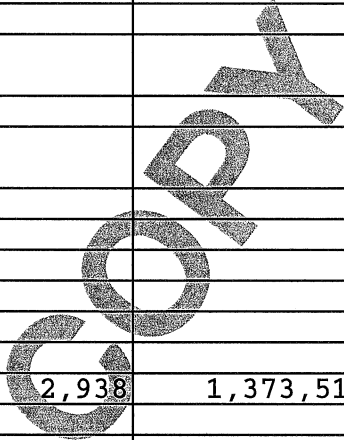
