Due to unforeseen circumstances the planned strategies to reach program goals and budget adherence were not achieved. Unplanned changes included the search for a new location for business and the cost associated with moving. This happened at the height of the organization's fund raising calendar. Moving costs forced a decision to access nonprofit's Building Fund. Many annual "holiday" supporters were left disconnected despite advertising the charity's change of address. Additional influences on the overall charity impact include: 1. a total of four interruptions to the weekly food bag distribution, 2. the curtailment of the seasonal advocating activities, 3. and the inability to accept several large food donations.

Even though these unforeseen circumstances had adverse effect on the overall distribution, the nonprofit managed to stabilize at 98% of previous 2014 accomplishments.
