WHETHER THEY ARE DEALING WITH HOMELESSNESS, DOMESTIC VIOLENCE, A MEDICAL EMERGENCY OR EXHAUSTION, HENNEPIN COUNTY FAMILIES CAN SEEK HELP AND HOPE FROM THE CRISIS NURSERY EVERY HOUR OF THE DAY, EVERY DAY OF THE WEEK.

WITH A 24-HOUR CRISIS HELPLINE, HELP IS JUST A PHONE CALL AWAY.
