- Supported our member entrepreneurs through on-site and off-site training, networking, fund raising, and education.
- Offered regular courses for certification of Food Safety Managers, according to the FDA standards and the ServSafe curriculum.
- Provided management and financial strategy, and operational support and training, helping our members create over 60 new stable jobs in the City of Boston, a majority of which are occupied by women, minorities, low-income individuals, and/or all of the above.
- Created and maintained a nurturing, collegial environment in which start-up entrepreneurs can share resources, education, and lessons learned, building a library of corporate memory for the future success of the mission.
- Graduated 5 enterprises out into stable operations in their own kitchen/processing facilities, a net gain of 45 new full time jobs.
