Thank you for choosing EN CPA FIRM, INC to assist with the 2022 taxes for NIRMAAN USA. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

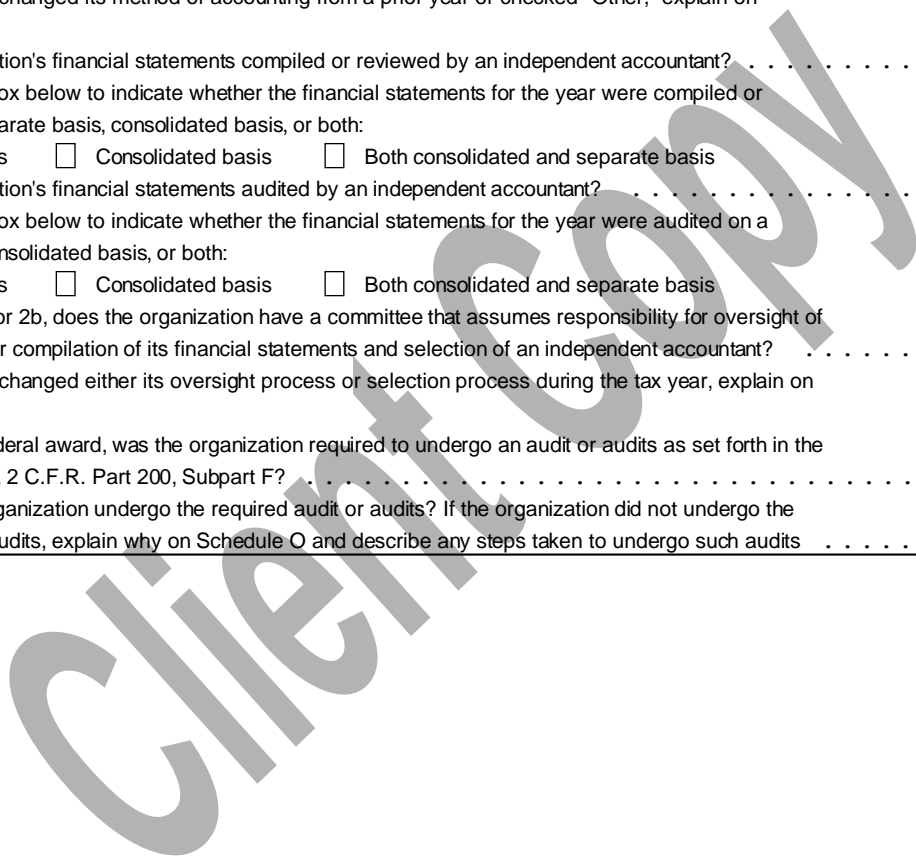

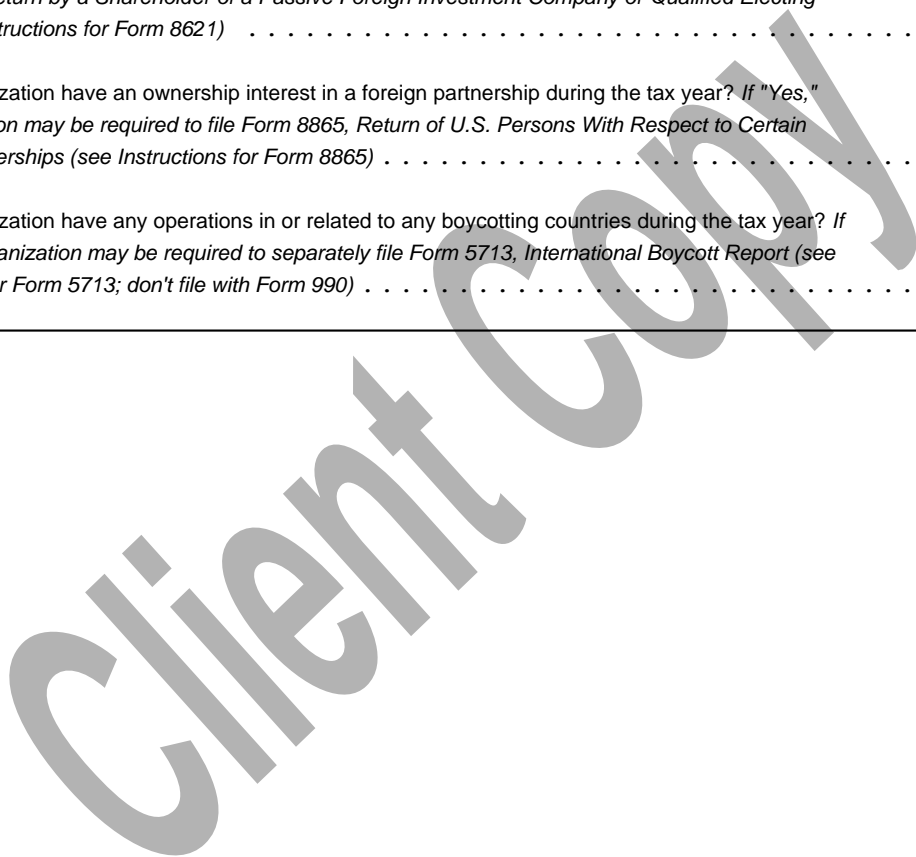

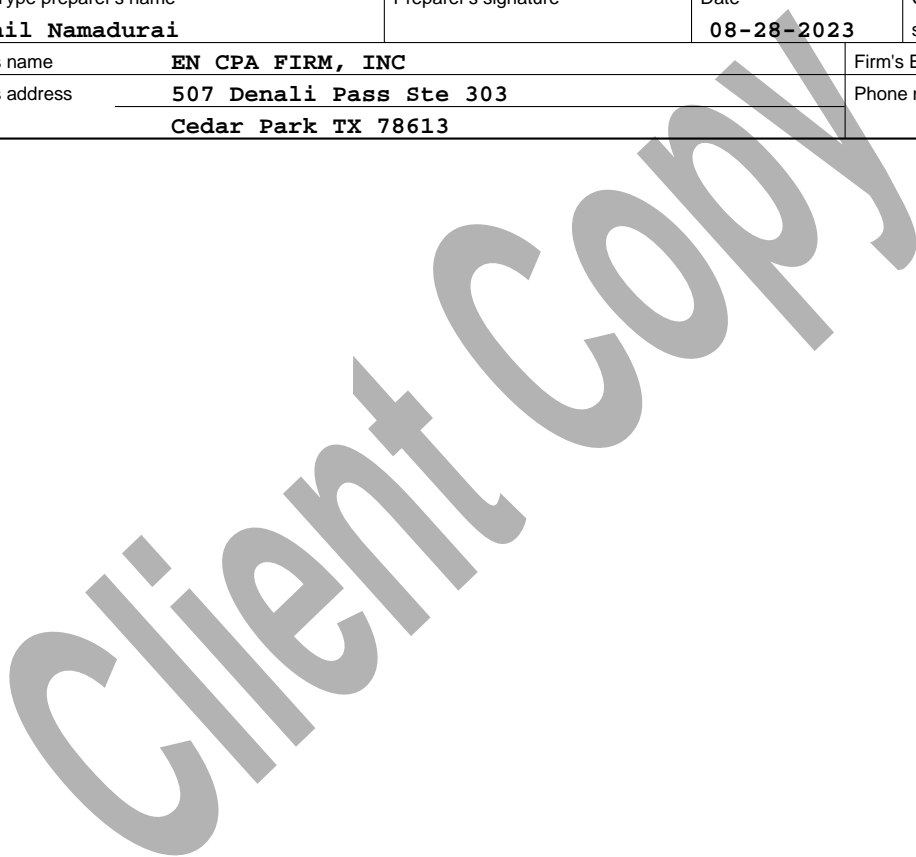
