We retrieved 106 DOA turtles and successfully released 35 turtles into the ocean. The rehabilitation program includes providing turtles with medical treatment, medicins, scans, surgeries, and any treatment or rehab needed to treat the injured or sick turtle.

The Education Program's objectives focus on educating and providing information to the public on conservation, marine sea turtles, rehabilitation, and being good ocean stewards. The objectives are accomplished via onsite education, field trips, and virtual programs and field trips. Through our education center onsite visitors learn about our mission and programs. Visitors have access to our turtle resident center and rehabilitation hospital. In 2020, there were 113,620 visitors to our facility and 7,046 students learned about our mission via field trips, online and onsite education programs.
